### SUMMARY

Robert Rosvall is an attorney at the firm's Pasadena office. Mr. Rosvall's practice primarily focuses on products liability and high-exposure property damage claims. Mr. Rosvall has successfully resolved dozens of wrongful death and catastrophic personal injury cases and has represented major retailers including Amazon.com and Wal-Mart in both federal and state court. ### EXPERIENCE

**Favorable Settlement for Touring Company:** Mr. Rosvall negotiated a favorable settlement on behalf of a touring company in a multiple fatality drowning case. Plaintiff was a Chinese national who watched his parents drown in front of him after a rogue wave hit a popular Northern California tourist attraction. Through aggressive discovery, including a 10-hour deposition of the plaintiff, Mr. Rosvall was able to resolve the case with less than a cost-of-defense settlement.

**Obtained Nondischargeable Judgment in Favor of Client:** Mr. Rosvall obtained an entry of a nondischargeable judgment against a sports promoter who solicited funds for an international soccer exhibition match from a local businessman shortly before filing bankruptcy. Mr. Rosvall was lead trial counsel in cross-examining the defendant, bringing forth several damaging admissions about the defendant's intent to file bankruptcy prior to borrowing the funds. As a result of the nondischargeable judgment, the client was able to recoup his life savings which were lent to the sports promoter.

**Favorable Verdict for Members of a Homeowners' Association:** Mr. Rosvall obtained a verdict in favor of seven members of a homeowners association after an aggrieved homeowner filed improper involuntary petitions against each of the members, disrupting their financial lives and ruining their credit
